Description of first aid measures

General advice

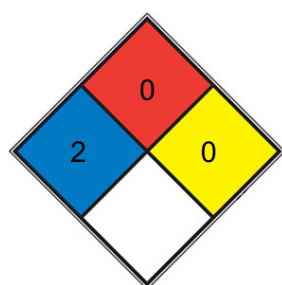
