### **Description of first aid measures**

#### **If inhaled**

### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

### **Persistence and degradability**

Biodegraded more than 80% in 48 hrs under the River Die-Away Test using both river sediment and river water Wemcol, 1% diisopropyl

### **Bioaccumulative potential**

An estimated BCF value of 69000 was calculated for diisopropylbiphenyl(SRC), using an estimated log Kow of 6.67(1,SRC) and a recommended regression-derived equation(2). According to a recommended classification scheme(3), this BCF value suggests that bioconcentration in aquatic organisms will be an important fate process(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc for diisopropylbiphenyl can be estimated to be about 160,000(SRC). According to a recommended classification scheme(2), this estimated Koc value suggests that diisopropylbiphenyl will be immobile in soil(SRC).

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
