## **SECTION 13: Disposal considerations**

### **Waste treatment methods**

#### **Product**

Offer surplus and non-recyclable solutions to a licensed disposal company.

#### **Incompatibilities**

Strong oxidizers; strong acids, produce a violent reaction, and deadly stibine gas (antimony hydride). Heat forms stibine gas. Mixtures with nitrates or halogenated compounds may cause combustion. Forms an explosive mixture with chloric and perchloric acid.

#### **Waste Disposal**

Recovery and recycling is an option to disposal which should be considered for scrap antimony and spent catalysts containing antimony. Dissolve spilled material in minimum amount of concentrated HCl. Add water, until white precipitate appears. Then acidify to dissolve again. Saturate with H<sub>2</sub>S. Filter, wash and dry the precipitate and return to supplier.
