Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

**Environmental precautions**

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### **Persistence and degradability**

Bis(2-ethylhexyl) hydrogen phosphite is subject to biological degradation in the environment(1); however, no specific data were provided(SRC).

### **Bioaccumulative potential**

An estimated BCF of 410 was calculated in fish for bis(2-ethylhexyl) hydrogen phosphite(SRC), using an estimated log Kow of 5.60(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc of bis(2-ethylhexyl) hydrogen phosphite can be estimated to be  $1.2 \times 10^4$ (SRC). According to a classification scheme(2), this estimated Koc value suggests that bis(2-ethylhexyl) hydrogen phosphite is expected to be immobile in soil.

### Disposal methods

#### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
