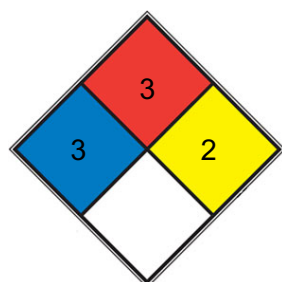

Body Protection
