##### **If inhaled**

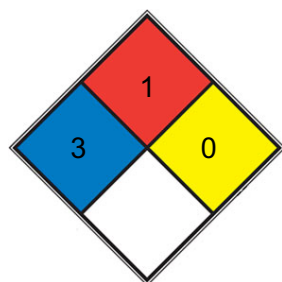

## SECTION 6: Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. **Persistence and degradability**

AEROBIC: While data specific to 2,4-dinonylphenol were not available(SRC, 2006), biodegradation of 2,4-dinonylphenol may be similar to that of structurally analogous nonylphenol which, based on microcosm studies using six soils, was considered generally biodegradable in well-

aerated arable soils(1). Nonylphenol was reported to have half-lives of 58 days in seawater(2), and 28 to 104 days in mesocosm experiments using sediment(3).

### **Bioaccumulative potential**

An estimated BCF of 3.2 was calculated for 2,4-dinonylphenol(SRC), using an estimated log Kow of 10.5(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 2,4-dinonylphenol can be estimated to be  $1.4 \times 10^7$ (SRC). According to a classification scheme(2), this estimated Koc value suggests that 2,4-dinonylphenol is expected to be immobile in soil. The estimated pKa of 2,4-dinonylphenol is 10.9(3), indicating that this compound will primarily exist in its unionized form in the environment.

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
