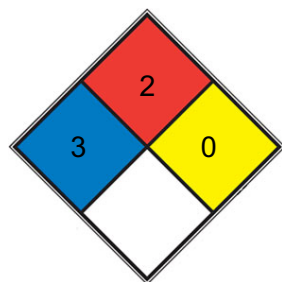

Eye/face protection
