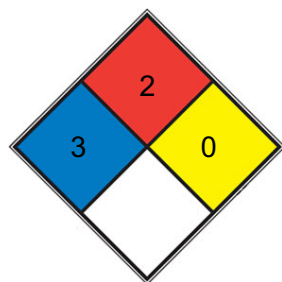

SECTION 6: Accidental release measures

Eye/face protection
