# Description of first aid measures

#### General advice

#### If inhaled

After inhalation: fresh air. Immediately call in physician. If breathing stops: immediately apply artificial respiration, if necessary also oxygen.

## In case of eye contact

Do not attempt to neutralise.

# **Extinguishing media**

# Suitable extinguishing media

Nitrogen oxides (NOx) Not combustible.
