A comatose patient who is diaphoretic, has pinpoint pupils and the odor of an insecticide on clothing or breath, and is noted to have muscle fasciculations represents the classic presentation of organophosphate poisoning. ... Specific steps in management include the following. 1. Decontamination. ... 2 Airway. Establish an airway if necessary. ... 3. Respiratory Status. Respiratory distress, in fact, is commonly found in these patients from multiple causes. ... 4. Cardiac Monitoring. ... 5. Cholinesterase Level. ... 6. Pralidoxime. Pralidoxime is the treatment of choice for organophosphate poisoning and should be used for nearly all patients with clinically significant orgnophosphate poisoning, particularly whose patients with muscular fasciculations and weakness. ... 7. Atropine. Atropine is the physiologic antidote for organophosphate poisoning. A trial dose of atropine should be instituted on clinical ground when one suspects organophosphate intoxication. # Persistence and degradability

lodofenphos had measured half-lives of 70.5 and 85.1 days in illuminated and non-illuminated soil, respectively(1). The main degradation product was 2,5-dichloro-4-iodophenol indicating that the main decomposition reaction was the cleavage of the aryl ester bond(1). Degradation was due to both abiotic and biotic reactions.

### Bioaccumulative potential

An estimated BCF value of 9000 was calculated for iodofenphos(SRC), using a measured log Kow of 5.51(1) and a recommended regression-Chemical Book derived equation(2). Guppies, Poecilia reticulata, exposed to a mixture of cyanophos, methylparathion, ronnel, fenitrothion, dicapthon, and iodofenphos had a bioconcentration factor of 48,000 for iodofenphos; an elimination rate constant of 0.36/day was observed for the same compound(3). According to a recommended classification scheme(4), these values indicate a very high BCF, and that short-term bioaccumulation will occur(SRC) based on a measured elimination rate in aquatic organisms(3).

### Mobility in soil

The Koc of iodofenphos is estimated as approximately 24,000(SRC), using a measured log Kow of 5.51(1) and a regression-derived equation(2,SRC). According to a recommended classification scheme(3), this estimated Koc value suggests that iodofenphos will be immobile in soil(SRC).

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
