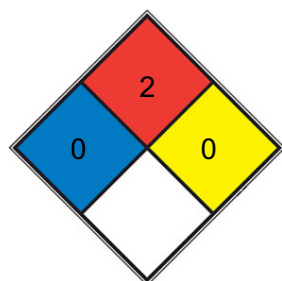

This substance/mixture contains no components considered to be either persistent, bioaccumulative and toxic (PBT), or very persistent and very bioaccumulative (vPvB) at levels of 0.1% or higher.

### **Toxics Screening Level**

Using the NOAEL of 1000 mg/kg from the gavage study, where (1 kg)/(0.93 m<sup>3</sup>) is the inhalation rate for Wistar rats as cited in EPA 1988. Therefore an AAC of 300 µg/m<sup>3</sup>, with annual averaging, should be acceptable.
