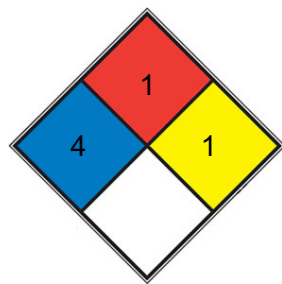

Skin protection
