**Indication of any immediate medical attention and special treatment needed****Absorption, Distribution and Excretion**

In vivo and in vitro studies showed significant uptake of (14)c-penicillic acid by red blood cells and a significant increase in radioactivity associated with the membrane fraction with time (1-4 hours). however, the majority of the blood cell activity was intracellular. the (14)c-radioactivity concentration in liver fractions (1.5% of the rna-dna and protein fractions. the level of the (14)c activity associated with these fractions increased with time (24 hr). studies of the in vivo metabolism of [(14)c] penicillic acid by rats showed that a significant amount of

radioactivity was excreted in the urine (82% of the administered dose after 7 days). biliary metabolites accounted for 10% of administered dose 2 hours after administration.

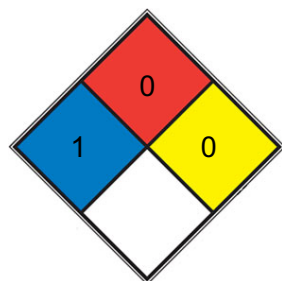
