SECTION 4: First aid measures

Description of first aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Most important symptoms and effects, both acute and delayed

SYMPTOMS: Symptoms of exposure to this compound include gastrointestinal and hepatic reactions such as anorexia, nausea, vomiting, gastralgia, abdominal cramps, diarrhea, tenesmus and transient elevation of SGOT. Other symptoms include central nervous system reactions, headache, dizziness, drowsiness, insomnia and skin rashes. Fever may also occur. ACUTE/CHRONIC HAZARDS: When heated to decomposition this compound emits toxic fumes of sulfur oxides and nitrogen oxides. (NTP, 1992)
